## Legal Update: Arizona Embraces Technological Advancements

Effective January 1, 2024, the Arizona Rules of Civil Procedure were amended allowing the use and acceptance of electronic signatures and notarized documents. The amendments mark a pivotal shift toward embracing modern technology in legal practices. Under Rule 5.1, "[t]he clerk must accept for filing any document that purports to have a signature, including documents that appear to be electronically signed or electronically notarized in accordance with applicable law. If the authenticity or sufficiency of an electronic signature or electronic notarization is disputed, a judicial officer will make a determination under applicable substantive law." Ariz. R. Civ. P. 5.1(f).

## Case Study: Arizona Court of Appeals Affirms Superior Court's Authority in Jurju v. Ile

In a recent ruling, the Arizona Court of Appeals held that a superior court has jurisdiction to enjoin a separate forcible entry and detainer judgment issued by a different court. Jurju v. Ile, 534 P.3d 926 (2023). The case involved two families working together to run a business. The first family obtained a forcible entry and detainer judgment against the second family, who later sought a preliminary injunction. The court granted the injunction prompting an appeal on the issue of whether the superior court had authority to do so. The Court of Appeals found an exception to the Injunction Limits Act, allowing for an injunction. The decision relied on facts emphasizing allegations of wrongful eviction and breach of contract. This confirmed the superior court's authority to issue the injunction, setting a precedent for such interventions.
